‘OHANA HEALTH PLAN ANNOUNCES LAUNCH OF NEW MEDICAID HEALTH PLAN SERVICING AGED, BLIND OR DISABLED MEMBERS

HONOLULU, HI (June 16 , 2008) — ‘Ohana Health Plan, one of two health plans awarded a contract to participate in the Hawai‘i QUEST Expanded Access (QExA) program, today announced it will provide managed care services to the Hawai‘i Medicaid aged, blind or disabled (ABD) population needing primary, acute and long-term care services. Services are expected to begin November 1, 2008.

“It’s an honor and privilege to come home to serve the people of Hawai‘i through the state’s Medicaid managed care program,” said Erhardt Hsiao-Lin Preitauer, executive director of ‘Ohana Health Plan and native of Kaua‘i. “We appreciate the opportunity we’ve been given to enhance our members’ quality of life, and we recognize the important role we play in their health and well-being.”

‘Ohana’s philosophy is to place members and their families at the center of the health care continuum. Our model is new to Hawai‘i and includes local Hawai‘i -based service coordinators to personalize interaction with members. Each member will be matched with an ‘Ohana service coordinator who will work directly with the member and multi-disciplined health care team to develop a proactive care treatment plan that meets medical and lifestyle needs. These service coordinators are licensed nurses or experienced professionals such as social workers who are trained in health care management.
