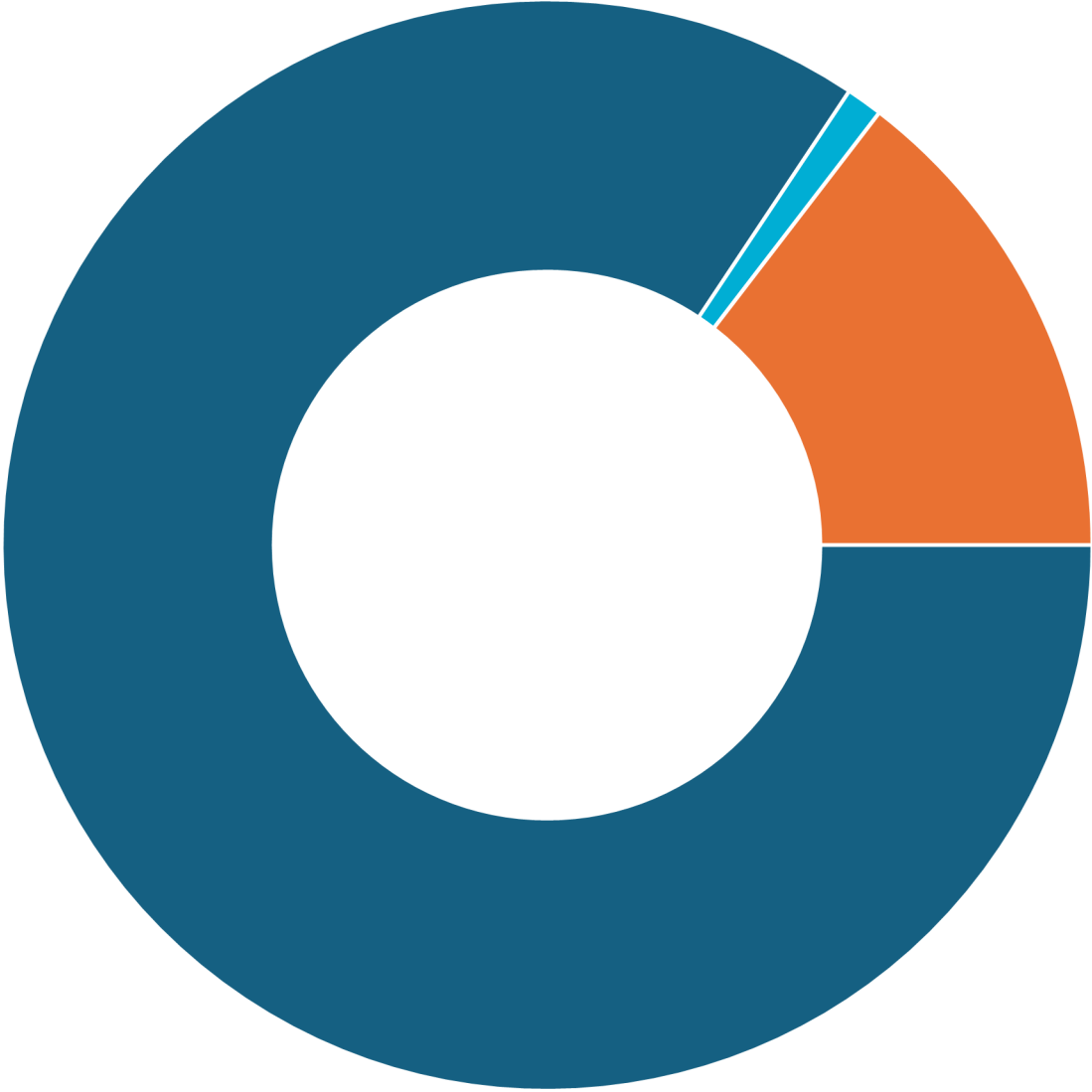

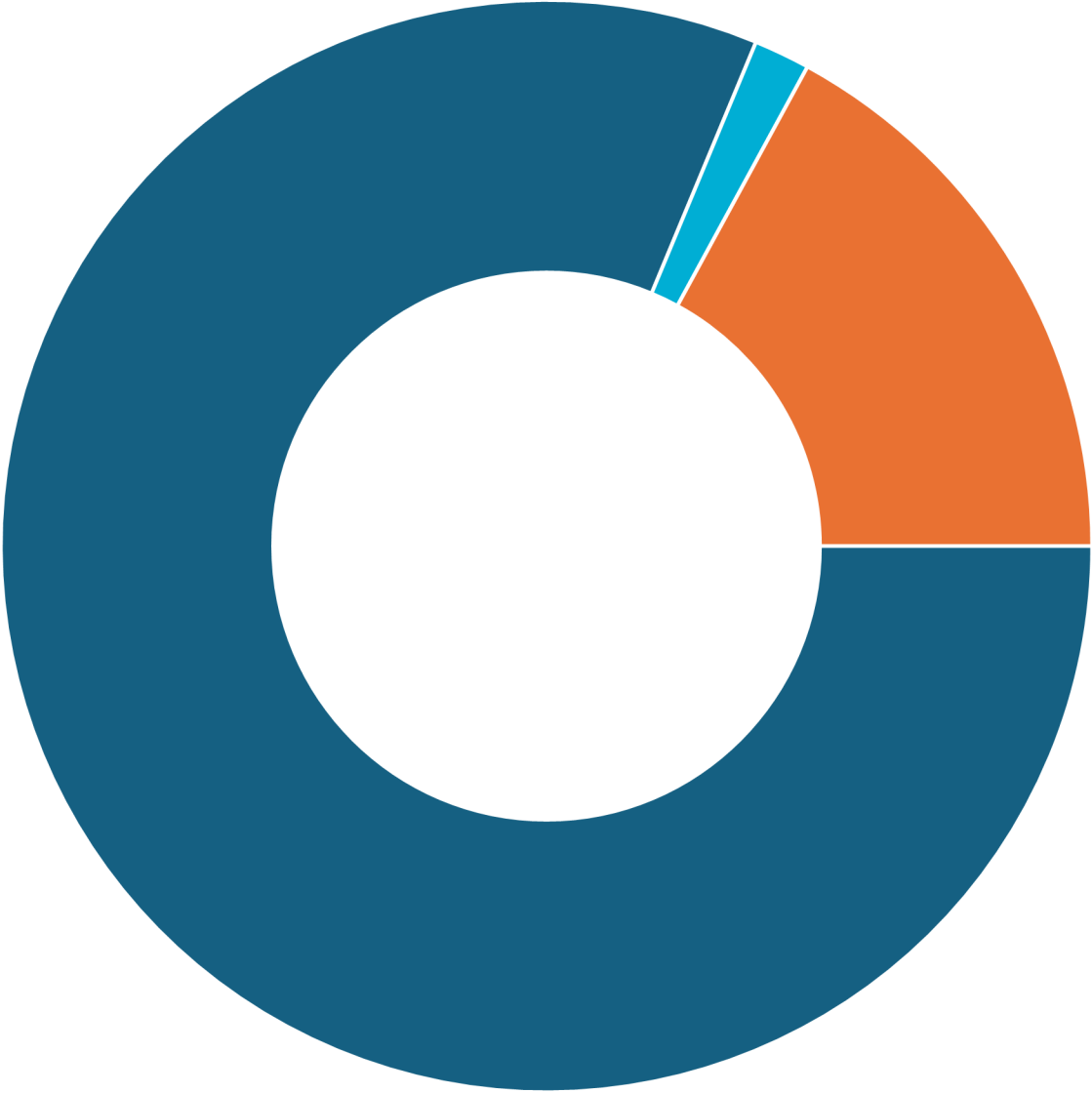
**85.27% of those requests were approved:**
