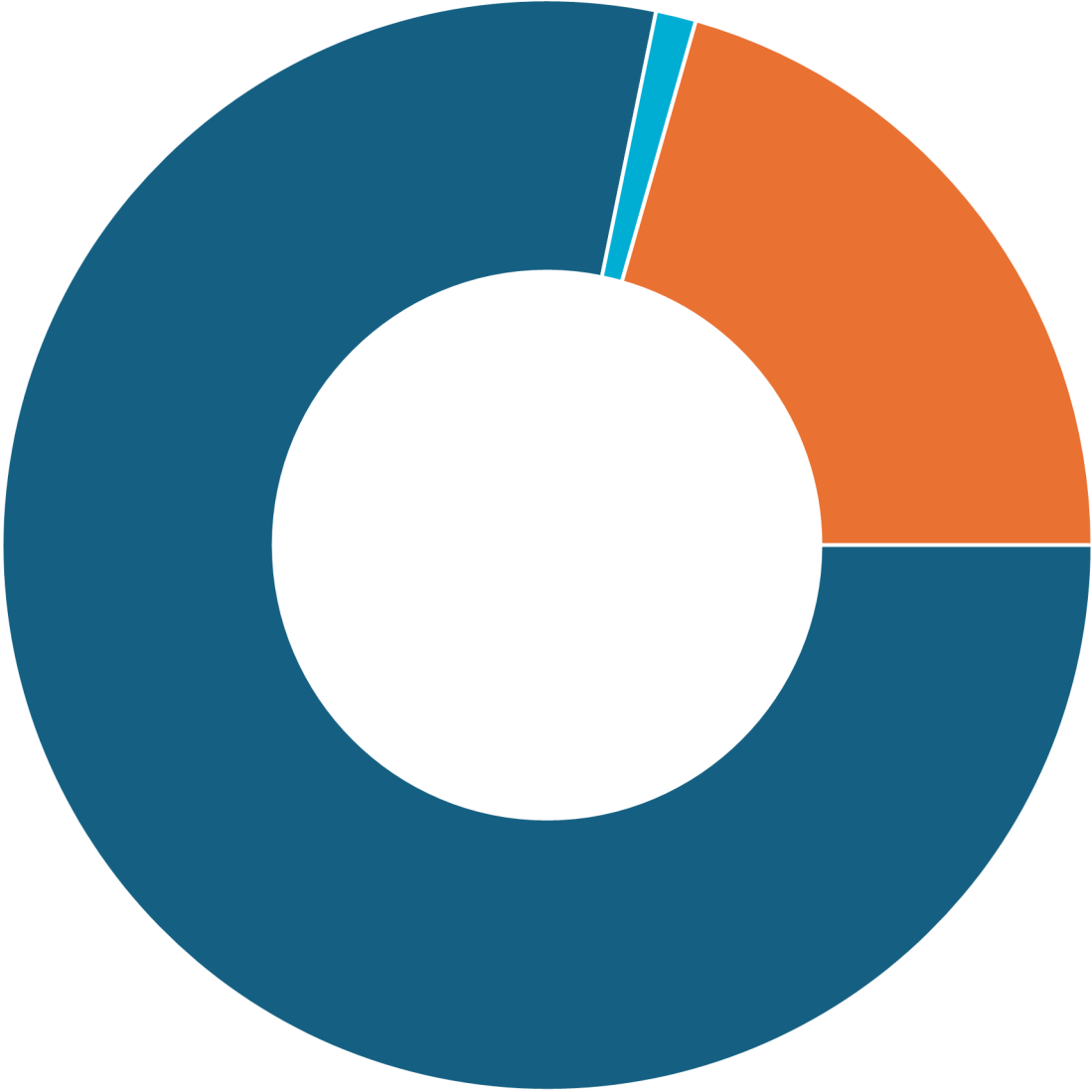

In 2025, Medicare: MA Contract: H4868 received a total of 90,696 standard (non-urgent) prior authorization requests for our covered patients.

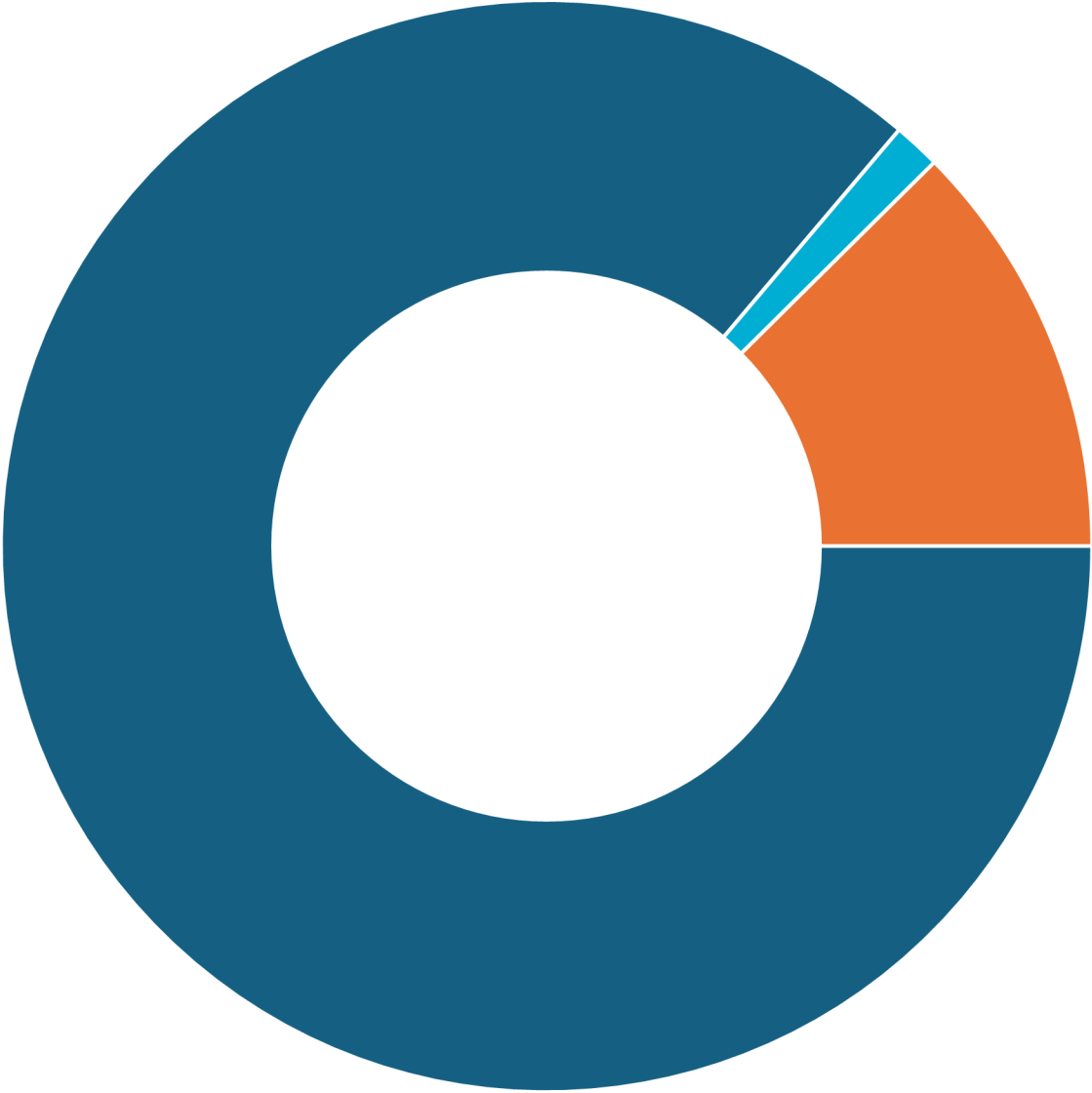
79.16% of those requests were approved:
